HOLDING TANK PUMPING FOR CAMP OWNERS

Effective May 28,2008

CAMP OWNERS ARE RESPONSIBLE FOR HAVING THEIR TOILET WASTE TANKS PUMPED BEFORE OVERFLOWING. YOU MAY USE ANY REPUTABLE CONTRACTOR.

THE CLUB WILL MAKE ARRANGEMENTS FOR YOUR PUMPING REQUIREMENTS WITH J.A.C SEPTIC SERVICE UNDER THE FOLLOWING CONDITIONS:

- 1. CONTACT THE PRO SHOP WHEN YOUR TANK NEEDS PUMPING. DO NOT CONTACT THE CONTRACTOR (J.A.C. SEPTIC SERVICE) UNDER ANY CIRCUMSTANCES. VIOLATING THIS CONDITION, OR FOR ANY OTHER REASON HE DEEMS APPROPRIATE, ALLOWS HIM THE RIGHT TO REFUSE SERVICE TO ANY INDIVIDUAL CAMP OWNER.**
- 2. REQUESTS MADE BY 4:00 PM WEDNESDAY WILL BE PUMPED ON THURSDAY OR FRIDAY, AS DETERMINED BY THE J.A.C. SEPTIC SERVICE.**
- 3. THE CONTRACTOR EXPECTS PAYMENT ON THE DAY OF THE SERVICE. A BILL WILL BE SENT TO THE CAMP OWNER IF NECESSARY.**
- 4. THE COST IS APPROXIMATELY \$100.00 PLUS 8 CENTS PER GALLON.**
- 5. FAILURE TO MAKE PAYMENT WITHIN TEN DAYS OF THE SERVICE WILL RESULT IN PAYMENT BY THE CLUB. A \$25.00 SERVICE FEE WILL BE ADDED TO THE TOTAL AND THE FULL AMOUNT WILL BE PAID TO THE CLUB BY THE CAMP OWNER. IF THIS OCCURS, THE CAMPER WILL NO LONGER BE PERMITTED TO USE THIS SERVICE, AND WILL BE REQUIRED TO OBTAIN PUMPING SERVICE ELSEWHERE.**
